There were 9 members of the public in attendance.

23/128 To receive Disclosures of Interests from Councillors on matters to be considered at the meeting.

There were no disclosures of Interest

23/129 To identify items for which the Press and Public may be excluded.

23/130 Public Participation Session

A member of the public indicated that he had responded to the latest revisions of the Wimpey Sheffield Halt Development and asked if Warmsworth Parish Council could do something similar - the Clerk agreed if he was sent the further objections.

A Teams meeting with interested parties and the developer is scheduled but dates have yet to be offered.

There were also some specific questions from attendees who had plots at the Allotments. These were to be discussed at the next Allotments Committee Meeting

A complaint was also made about a large van which the complainant thought was parked illegally on the corner of a street which was thought illegal. He was urged to report this to the police.

At this stage, all the members of the public in attendance .left the meeting.

23/132 Unresolved Items from Previous Minutes

- a. Lords Head Lane Petition This was requested to remain on the agenda, renamed to Lords Head Lane, One Way, Cycle Path, and Pedestrian Way, alongside Sheffield Road proposed development onto the Halt, with the Broomhouse Lane Development it was reported that the Broomhouse Lane Development was making the exit onto Lords Head Lane wider objections had been lodged with Doncaster MBC. One way down from Warmsworth to Broomhouse Lane was still being promoted by the Parish Council ONGOING
- b. Grass Cutting KG Field The Cricket Club has accepted the new cutting agreement which has been signed and the mower still had one installment to be paid later this year. The cutting by the contractor was doing well and the Lions had asked for an extra cut for the new season which was being paid for by the club The cutting contract would be monitored into 2024 and would be revisited if more cuts are deemed to be required COMPLETED
- c. Progress on Summer Activities these were successful despite a slight pause for bad weather. There was no funding this year, but the Clerk agreed to look for funding earlier next year to cover the costs and still making the well-attended facility free <u>COMPLETED</u>
- d. Root Problem from holiday Inn trees the manager of the Holiday Inn had been contacted several times and had agreed verbally to look for a date for a meeting sometime soon. The Clerk will write again to establish some dates - <u>ONGOING</u>
- e. Defibrillator Clerk had made some initial enquiries if funded by the Parish it would be around £1.5

 £2k less VAT there may be some funding streams which were available to partially fund this in the past, but it was by no means certain that funding could be obtained, Cllr Cole knew a contact and would alert the Clerk <u>ONGOING</u>
- f. Signage and Dog Fouling most signs have been ordered and installed but three more strongly worded signs are still to be ordered as agreed The Clerk will contact the supplier ONGOING
- g. Police Presence in Warmsworth The Clerk had made contact on a couple of occasions with the local police mainly PCSO's they agreed to send him the shift patterns so that attendance on a regular basis can be established it was mentioned a police presence around Halloween / "Mischief" Night and the possibility of 2operation Divert" funding next year to keep young people active on non- ASB related activities ONGOING
- h. Yorkshire Air Ambulance Appeal for Funds specific funds to be donated from Parish reserves was rejected by Councillors under Section 137. However, it was agreed to make YAA the Parish Council's "Charity of Choice" and urge residents to donate directly to them through a link in the Parish Council Website this was especially relevant as the helicopter was called to a recent serious accident in Warmsworth ONGOING
- Popples for Lamp posts at Remembrance and the order of an annual wreath all done and ready Clir Pattison will liaise nearer the time - <u>COMPLETED</u>

23/133 To Resolve that the Risk Register has been reviewed and any additions to notified and reviewed.

During the summer break, the Clerk had been busy updating the register and inserted a new tab for Fire Risks in the new Hub. The Register was accepted but it was mentioned that there was a need to review the risks at the Allotments – the Clerk would look into this.

RESOLVED: That the Revised Risk Register is accepted and will be reviewed again in around 6 months and the Clerk is to review and compile a new Risk Register for the Allotments

23/134 To Decide upon a suitable co-option to replace resigning Councillors.

There was still one Casual Vacancy for appointment and the Chair as well as others were asking certain local residents to express an interest. It would also be placed on the noticeboards – it is already on the website.

23/135 To Hear Reports on the work of External Bodies

a. Allotments - Clirs. Bennett / Beech / Maxey

A further Committee Meeting is to take planned for some time to be confirmed in September. There was some concern that the figures indicated there may be a case for an increase in fees, however all Councillors agreed that the fees for an allotment would be frozen for another year but were one of the cheapest for even the largest plot in the Doncaster MBC area.

- b. <u>Environmental Group / Playing Fields</u> Cllr Pattison gave a brief written report which was issued to all Councillors:
- The Don Gorge & WEG group are requesting a new litter bin on the lower Hairpin adjacent to the bridge.
 The angling club are leaving their rubbish on the roadside expecting others to pick it up, so we need a
 litter bin. The owner of the land has repaired the fencing on the lower bend. He is the owner so
 responsible for its maintenance and hopefully we will have no more cars driving through it!

Don Gorge Group has also offered to help the Handyman / Gardener to install the poppies on the lamp posts for Remembrance Sunday.

- On going problem with the lock on the Guest lane bridge gate to access the cemetery. The Chair has emailed DMBC Cemetery Manager, and we are still waiting a suitable reply. This is not a Parish Council responsibility.
- Levitt Hagg Manager still trying to organise a contractor to install the green path along the Levitt Hagg road.
- 4. Thank you to Cllr Jo and Mr Simon Auty for offering to monitor the Cecil / Wrightson backs and prepared to report any dumping or other problems.
- Problem with dust deposited on Sheffield Road from trucks leaving the Sibelco site. The Site Manager has informed Cllr Pattison that the 'Dust suppression system" had failed. They are running the system manually until the issue is resolved.

Also, the hedge cutting contractors for Sibelco are working in September, so we need to check if the allotment and KGF hedge is ready for cutting too.

- 6. DMBC Community Liaison Officer, has organised for a gardening team to work in the Quarry Park on the 10^{th.} October, planting 30 Yew hedge shrubs. The others are to be used to replace the dead shrubs in the old Centre Garden. There are still a few parts of the upgrade for the park to be agreed but The Officer has reassured Cllr Pattison that the 106 monies originally agreed are still ring fenced for the Quarry Park and once all contractors and plans are in place the money can be accessed.
- 7. The Lions Football committee are happy to emulsion the interior of the pavillon if we agree to pay for the emulsion and brushes. The pavillon interior was painted by a local decorator and paid for by the Parish Council many years ago so would be cost effective for us to agree to buying the paint.

- 8. Suggestion that the unused notice board in the front garden of the old centre would be better placed in the grounds of our new building if Jo does not need it. It does need a repair but is looks in good condition so would be a useful notice board for outside use. Sadly, we have had 2 of the new shrubs stolen from the community Hub garden, it is disappointing, but we will not give up!
- 9. The union jack we are flying is faded and not fit for purpose could we please purchase a new good quality flag?
- c. Cricket Club Clir Bennett reported that both teams had been promoted this season

- f. PROW Cllr Pattison had spoken about footpaths in her update
- g. <u>DTUG</u> The Clerk reported that from the beginning of September, most evening and Saturday routes after 8pm had been cut back to one an hour and Sunday services were similarly affected.
- h. <u>Don Gorge</u> Clir Bennett had attended the meeting that morning. The field by the river on the Warmsworth site was a target to be adopted from Doncaster MBC and there were plans for a campsite. A site for a bench was requested from the Parish Council Clir Pattison agreed to liaise with Clir Bennett on this.
 - it was also suggested that a dragon boat race between Sprotbrough and Warmsworth Parishes could attract interest and raise funds.
- i. Quarry Liaison Nothing to report.
- Accounts Inspection The Chair and CIIr Beech are to arrange an inspection for the first accounting quarter.
- k. HR Issues There were no issues and the HR Committee had not met recently.
- Gala Committee No meetings had been attended recently.
- m. <u>YLCA South Yorkshire Branch</u> The Council does not have a representative at present. Next meeting scheduled for 25th October The Clerk always circulates the information on these meetings.
