23/163 To receive Disclosures of Interests from Councillors on matters to be considered at the meeting.

23/165 Public Participation Session

There were no members of the public in attendance

23/166 To resolve that the minutes of the meeting of the Council held on 9th. October 2023 be signed as a correct record.

23/167 Unresolved Items from Previous Minutes / Clerk's Update

a. Lords Head Lane Petition – This was requested to remain on the agenda, renamed to Lords Head Lane, One Way, Cycle Path, and Pedestrian Way, alongside Sheffield Roads proposed development onto the Halt, with the Broomhouse Lane Development – awaiting further action from DMBC Planning Department – it appears Highways are making the entrance to the site wider and closing Long Lands Lane for a week – ONGOING

- b. Root problem from Holiday Inn Trees Hotel Manager has been approached Constructive recent meeting at the Holiday Inn – The Parish Council had written to DMBC pointing out that work was necessary to avoid a tripping hazard and the Manager at the Holiday Inn was also in correspondence to get the matter resolved – needs a further follow up – <u>ONGOING</u>
- Defibrillator Attempting to obtain some quotes and possible assistance from YAS YYAS contacted

- d. Signage and Dog Fouling KGF Signs were ordered the items ordered had been installed more signs requested in blue Clerk still to sort **ONGOING**
- e. Police Presence in Warmsworth Police been to see Centre and talk with Clerk some more work necessary with Clerk and Police on using Hub regularly but another meeting with PCSO is planned -ONGOING
- f. Yorkshire Air Ambulance YAA contact keen to have publicity on our website and to become Parish Council "Partner of Choice" also keen to establish talks with some of our users WI / Women's Group etc. COMPLETED
- g. Risk Register for Allotments to be revisited / Updated will be inspected by Allotments Committee first - Clerk looking at this – Cllr Bennett agreed to assist with this before scrutiny by the Committee. Clerk found several risks assessed over time for allotments and will incorporate into WPC Risk Register – ONGOING
- h. Update on Christmas Fayre Cllr Beech sorting lots of ideas Cllrs Lenham & Auty assisting been advertised to take place on Sunday 10th December all vendor stalls have been sold Christmas tree to be donated to Centre and need a marquee Chair will approach Gala Committee **ONGOING**
- Complaint about overgrown hedges from a property intruding into Allotments Property owner notified and awaiting response - <u>ONGOING</u>

23/168 To Decide upon a suitable co-option to replace resigning Councillors.

There was still one Casual Vacancy for appointment and the Chair as well as others were asking certain local residents to express an interest. It would also be placed on the noticeboards – it is already on the website.

23/169 To Hear Reports on the work of External Bodies

a. Allotments - Clirs. Bennett / Beech / Maxey

Inspection of plots had taken place and payments for this years subs were underway with a positive response generally. There were some issues over who had paid and also vacant plots or plots neglected which would be referred to next Committee Meeting as would issues raised by the recent face to face with a select number of potholders — another would be arranged for the New Year.

b. <u>Environmental Group / Playing Fields</u> – Cllr Pattison had sent a brief written statement in which she had decided to concentrate more on her role in the Warmsworth Environment Group and less time on related Parish Council local environmental matters – this would not however see her relinquishing her

responsibilities as a Councillor which would continue. She felt that some of her concerns had been overlooked.

- <u>Cricket Club</u> Custom at the regular club members, especially on Sunday lunchtime, was reducing and a Stakeholder Meeting on the King George Field with the Club and the Lions has been deferred until January 2024.
- d. Football Club Nothing to report except the promised cleaning needs to be inspected at some point soon.
- e. PCJCC No meeting
- f. PROW Cllr Pattison. Reported that she had been making further inquiries about the "green path" at Levitt Hagg it was established that this is a Public Right of Way and she will make further enquiries in the New Year.
- g. <u>DTUG</u> Supertram lines were being upgraded, Meadowhall and Sheffield Interchange had proposed resurfacing work and the City Region Mayor was fronting a campaign to getter better funding for local buses in South Yorkshire which in some cases had disappeared or had been severely cut back over the last 20 years.
- h. <u>Don Gorge</u> there are to be 400 trees from the Woodland Trust to be planted in Don Gorge next March. There was a need to repair and replace the benches along the river damaged by recent flooding. It was also reported that Officers from DMBC attended the meeting and would source a new litter bin in the Hair pin area. BT has also offered volunteers to assist the work of Don Gorge Group.
- i. Quarry Liaison A member of the public in Warmsworth had put themselves forward to be a community liaison with the quarry
- j. <u>Accounts Inspection</u> The Chair and Cllr Beech had conducted a recent audit and had found the system quite straightforward Councillors were assured that all was good but the process took a little time.
- k. <u>HR Issues</u> There were no serious issues. The Clerk mentioned to Councillors that the new rates of pay for staff had been agreed nationally and would be implemented immediately and explained the changes.
- Gala Committee No meetings had been attended recently. The Chair wished to be removed from this
 committee.
- m. <u>YLCA South Yorkshire Branch</u> no representative at present the last meeting was at the end of October.

23/170 To Discuss items arising from the Stapleton Road Implementation Committee

There had been a meeting to discuss the Art Club's objection to being reprimanded for coming in too early. Some other groups may face the same problem, but this is being handled as amicably and as sensitively as possible.

Discussions were ongoing for a possible Community Radio project for Edlington and Warmsworth based at the Hub, but this required further discussions and was subject to funding.

23/174 To Discuss Financial Matters

RESOLVED: The payments, Budget & Bank Reconciliation to end of October 2023 be approved and signed as a true Record.

The cost of the elimination of rat infestation at the Allotments was queried and could it not be scaled back to save money – however it was thought that the contractors were effective and did useful work for the council elsewhere in Warmsworth at the old Community Centre (mice) and on the King George Field (moles) all these contracts were combined to give the best value and appeared to be working well.

23/175 To Discuss Remembrance Day Plans

The arrangements would be the same as last year, the wreath was in the office, and the Clerk would contact all those involved to request attendance on Remembrance Sunday at 11.00am. The PA would also be inspected, and the recordings would also be re examined again by the Clerk.

23/176 To Consider Resolutions Notified by Members

- Tara Lounge Concerns over charges being implemented for parking however there was nothing that Warmsworth Parish Council could do about this.
- Edlington Food Bank assistance could be offered from Warmsworth PC but it would need someone to run and co-ordinate it which could prove difficult for the Council with limited resources.

The Clerk reported that DMBC was keen to activate the Hot Spots initiative and would investigate further – a session could be held as there was no one in the centre on Fridays.

 Speeding along Tenter Lane – the Parish Council has made numerous attempts with petitions and campaigning to DMBC but there was a reluctance however supportive Councillors were to get involved again unless someone on Tenter Lane started and ran the campaign.
