

WARMSWORTH PARISH COUNCIL COUNCIL MEETING

Minutes of the Parish Council Meeting held on 8th. January 2024 at 7pm at Warmsworth Stapleton Road Centre.

There were 7 members of the public in attendance.

Per the Agenda, The Chair reminded Councillors present that following legitimate complaints about behaviour, all Councillors should adhere to and respect Standing Orders and the Code of Conduct at all times. They should not talk over other Councillors and indicate to the Chair that they wish to speak.

24/001 To receive Disclosures of Interests from Councillors on matters to be considered at the meeting.

There were no disclosures of Interest

24/002 To identify items for which the Press and Public may be excluded.

Items 8(k), 12(t) and 18 were identified but not invoked.

24/003 Public Participation Session

A member of the public that was keeping an eye on the proposed Wimpey development gave an update as he saw it with Doncaster Council's Urban Design and Ecology Teams both objecting and with valid reasons.

The development had been downscaled slightly to 114 houses which was still more than the original outline and some of the proposed properties were still not in keeping with the privacy of neighbouring existing bungalows.

There were also serious concerns over disturbing a mixed bat population present in caves in the field where the development will take place – Bats hibernate in Winter and are protected in Law.

The same person raised about having a defibrillator available to residents in the Ashdale Road / Halt area. The Parish Council was looking into paying for their own outside at the Hub, and the Ashdale / Halt idea was encouraged.

Several points were also raised about the Allotments:

- · Sign to re-direct Delivery Drivers
- · A pothole developing where a cable had been laid
- Feedback from Committee to be placed on the Allotments noticeboards
- Question over who cuts the grass linking allotments?
- Re-letting of plots in disrepair
- No committee of Allotment holders so where can complaints be made?

All of these were noted by the Chair who indicated that he would be taking personal responsibility for the points made and indicated that if there were grievances between the focus groups, then it was the individual plot holder to raise these with The Parish Council Committee through the Clerk.

All the members of the public then left the meeting except one person who remained for the rest of the meeting (subject to Press and Public being invoked)

24/004 To resolve that the minutes of the meeting of the Council held on 13th. November 2023 be signed as a correct record.

24/005 Unresolved Items from Previous Minutes / Clerk's Update

- a. Lords Head Lane Petition This was requested to remain on the agenda, renamed to Lords Head Lane, One Way, Cycle Path, and Pedestrian Way, alongside Sheffield Roads proposed development onto the Halt, with the Broomhouse Lane Development awaiting further action from DMBC Planning Department it appears Highways are making the entrance to the site wider and closing Long Lands Lane for a week. It was reported that recent storms had caused ONGOING
- B. Root problem from Holiday Inn Trees Hotel Manager has been approached Constructive recent meeting at the Holiday Inn – Cllr Pattison to update – awaiting further contact from DMBC – ONGOING
- c. Defibrillator Attempting to obtain some quotes and possible assistance from YAS YYAS contacted awaiting response No response Clerk to follow up in January **ONGOING**
- d. Signage and Dog Fouling more signs requested in blue Clerk to sort in January ONGOING
- e. Police Presence in Warmsworth Police been to see Centre and talk with Clerk some more work necessary with Clerk and Police on using Hub regularly but another meeting with PCSO is planned **ONGOING**
- f. Risk Register for Allotments to be revisited / Updated will be inspected by Allotments Committee first - Clerk found old Risk Registers – need reviewing – to be presented to Committee in January and ratified by Parish Council in February - <u>ONGOING</u>
- g. Report Back on Christmas Fayre Cllr Beech indicated it was a great success, most Councillors and the Clerk assisted The Raffle generated £150 for Yorkshire Air Ambulance. An Easter Fayre was planned - <u>ONGOING</u>

24/006 To Decide upon a suitable co-option to replace resigning Councillors.

There was one expression of interest who was asked to write to the Clerk – the appointment would be debated and hopefully approved at the next meeting.

Cllr J Auty indicated her resignation from the Parish Council on which she had served since 2007 – the formal acceptance of the resignation would take effect at the end of the February 2024 meeting and measures would be put in place to elect a new Vice Chair for the March Meeting as well as notifying DMBC Elections unit of the resignation.

24/007 To Hear Reports on the work of External Bodies

a. Allotments - Clirs. Bennett / Beech / Maxey

Most plot holders had paid their fees on time, those who had not would be considered at the next Committee meeting, which was set for Monday 15th January at 6.30pm. Items raised at the last Consultation Group and also those raised by the visitors this evening would also be discussed.

b. Playing Fields

Cllr Pattison reported that since a tree had been removed by the King George Field, the crack in the historic wall had widened. She had tried a guy who claimed to be experienced at this type of thing but was unavailable and had since resorted to a small company that had done previous work for the Parish Council of a similar nature. This would not be cheap but had been budgeted for. — around £1700 plus VAT.

A Stakeholder Meeting with the representatives of both the Football and Cricket Clubs had been scheduled for 10th January

The Funding awarded for the improvements in the Quarry Park were continuing – a new seat and a litter bin were not in yet and improvements to the pathway cannot be done until an improvement in the weather.

The Clerk was also asked to write to Doncaster Council and Highways England about the disgraceful state of the entries and exits to the A1(M) at Warmsworth – litter has been there for a very long time.

- c. Cricket Club The number of members attending the Club appears to be dropping
- d. <u>Football Club</u> The Fire extinguishers in the Lions Building have been checked recently with no problems and the state of the kitchen is to be raised by councillors at the Stakeholders Meeting.
- e. PCJCC No meeting
- f. <u>PROW</u> Cllr Pattison reported that £18k had been spent by the owners of the road at Levitt Hagg the access was better for walkers and vehicles but not perfect.
- g. DTUG Nothing to Report
- b. Don Gorge the path from Fish Pass to Levitt Hagg was being improved and raised and litter had been removed by Doncaster Council from Mill Lane they reported to be finding it "difficult to work there"

It was also hoped to secure capital funding to improve the route between Fish Pass and Conisbrough.

The litter bin at the top of the hairpin has been re located to the bottom as it is difficult to empty but will cause more litter at the top – that was what it was there for.

Four folding tables, a large gazebo, and a generator are offered to the Parish Council by Don Gorge on permanent loan which were gratefully accepted.

- i. Quarry Liaison Not met
- Accounts Inspection A further inspection would be scheduled with nominated councillors at year end early April.
- k. <u>HR Issues</u> There were no serious issues. The Clerk and Cllr Cole had agreed a date to meet for a "catch up"
- Gala Committee No meetings had been attended recently. Councillors were disappointed at being
 charged for the Gala gazebo for the Christmas Fayre The Council refused on the basis of the charge. A
 local resident had a suitable replacement for free which was gratefully accepted.

RESOLVED: That the precept for Warmsworth Parish Council for the Financial Year 2024 – 2025 is increased from £53,000 to £55,000 and will be notified to Doncaster Council accordingly.
