22/083 To receive Disclosures of Interests from Councillors on matters to be considered at the meeting

Agenda Items 7k, 7n and 16 were identified by the Clerk and would be invoked if necessary.

22/085 Public Participation Session

There was one member of the public present who wished to give an update on Don Gorge and what the Parish Council's role had been.

The person present agreed to remain until that matter was discussed under "Reports"

The Clerk was asked if the procedure at present for members of the public to speak was in fact in accordance with Standing Orders. He agreed to place a revised set of words which would be directly lifted from those Orders for future meetings, and they would appear on the agenda.

22/086 To resolve that the minutes of the meeting of the Council held on 9th. May 2022 be signed as a correct record.

22/087 Matters Arising from Previous Minutes

a. Stapleton Road Resource Centre - Acquisition - The lease was now signed and approved and subject to a few small rectifications by DMBC, the lease and the keys would be in the possession of Warmsworth Parish Council in a very short period of time. Some items had been purchased from a grant to furnish the property a little - **ONGOING** 1/1/20

- b. Lords Head Lane Petition –Some trees have been cleared at the site and further clarification is being awaited. It was agreed to write to Doncaster MBC Highways about the access onto Lords Head Lane being shut off as access should be from Broomhouse Lane for developers and to express concerns about further traffic along Lords Head Land and propose that it is made one way as the lane is unsuitable for further traffic ibn both directions. Cllr Cole was giving this his support and pushing DMBC for a decision as soon as possible ONGOING
- c. Parking on Low Road West Appears to have abated somewhat but still being monitored **ONGOING**
- d. Results of Fire Inspection Still needs to be a special door stop and door alarm fitted which should be done at very shortly. The Clerk will arrange with the Contractor A separate fire risk evacuation plan needs to be done for the Centre Clerk will action these **ONGOING**
- e. 20mph Zones Clirs awaiting update from DMBC Councillors DMBC clearly not on board with this agreed to leave on further discussion agreed to leave on the agenda for now **ONGOING**.
- f. Hairpin fence / dumping recurring theme Site meeting with DMBC produced little and no promises, however after further prompting by Cllr Cole there appears to be a plan for limited mitigation in the installation of some more impact bollards and / or some more chevrons to indicate a sharp bend more clearly– **ONGOING**
- g. Damage to Fence on Allotments by Contractors Clerk to notify developers for action **ONGOING**

22/088 To Hear Reports on the work of External Bodies

a. Allotments - Cllr. S Auty / Lenham

A second "focus group" with selected members at random is planned after the success of the first. The Committee now had two quotes for re surfacing the road and awaited a third.

- b. <u>Environmental Group / Playing Fields</u> Cllr Pattison produced a short, written report on progress, and invited questions & Comments :
- Lack of police support and patrols regarding the groups of youths coming
 in our parks. Councillors were concerned and asked the Clerk to write to the local police to request a
 presence at the Parish Council to answer questions.
- Ongoing problems with the grass cutting on the KGF a site meeting has been arranged with DMBC to discuss the cost of a contract to resolve the problems we are having
- 3. DMBC have installed a planter on Sheffield Rd adjacent to the bus Stop, Clir Robertson has offered to water the planter when needed.
- 4. Gardener / Handyman is very happy with the 3 pieces of equipment the WEG purchased for him through a grant for Environmental support.
- 5. Request of DMBC to remove the weeds and clean up the gutters in the Cecil and Wrightson backs.
- 6. Request of DMBC for a double litter bin outside the Pizza and Chinese on Edlington Lane. The single bin is constantly full which is a positive with the amount of litter created from both food outlets.
- 7. Grasses are now ready to be planted at the Warmsworth boundary sign on Edlington Lane.
- 8. Request to Open Reach for the removal of the redundant cable box entrance to the Quarry Park Low Rd West and the under-used, dirty and vandalised phone box at the crossroads. The phone box is mainly used has an advertising board.

- 9. Union Jack was flying high for the Jubilee but unfortunately there was not enough bunting to give a good display and the rest of the bunting arrived too late to be installed.
- 10. The 2 new benches have arrived on the Halt to be installed by Ben Bailey before they leave the site.
- 11. Sent a request to both Ward Councillors for a grant to support a summer holiday scheme ran by Jo Halstead. Also applied to Lisa Johnson for the risk assessment forms in readiness for the use of the MUGA in August
- c. <u>Cricket Club</u> Risk assessments had been received and permission was given for the Jubilee Event on the King George Field.
- d. Football Club Light in the Lions building needed sorting the Clerk was aware and was asking the contractor to schedule.
- e. PCJCC Nothing to report.
- f. PROW There is to be a temporary closure of part of the Trans Pennine Trail in order to lay some cables
- g. <u>DTUG</u> Nothing to report
- h. <u>Don Gorge</u> The member of the public gave an update as he had attended the meeting to reconstitute the Group. A new and smaller Committee has been established and he wondered how much Warmsworth Parish Council had done.

It was explained that the Parish had supported the concerns of members and had considered a complaint to the Charities commission but decided against it as someone else had done so.

The Parish had also supported the Clerk at Sprotbrough in acting as an impartial go-between to establish a new dialogue and a way forward.

Councillors welcomed the efforts and the newly constituted Gorge Group.

- i. <u>Quarry Liaison</u> Cllr Cole to seek another "stakeholder" meeting with Quarry management which was now well overdue.
- J. <u>Accounts Inspection</u> Next quarterly inspection due when June accounts had been completed in July The Clerk will arrange.
- k. <u>HR Issues</u> Nothing to report except Cllr Cole has agreed to step in as substitute to Cllr J Auty for a short period.
- Gala Committee A special newsletter formulated by the Parish Council to publicise the Gala has been sent to the printers and will be distributed shortly. Cllr Maxey was agreed as WPC representative to this committee.
- m. <u>YLCA South Yorkshire Branch</u> The next meeting is due, and the Clerk had sent out the necessary details it was a meeting mid-week at Askern Town Council.
