# Unresolved Items from Previous Minutes / Clerk's Update

- a. Root problem from Holiday Inn Trees Cllr Pattison will update a further meeting scheduled with the Holiday Inn for 7 March 2020, but cancelled by the hotel - Cllr Pattison will reschedule for as soon as possible – ONGOING
- b. Signage—signs about Disabled gate keys have been received awaiting fitting COMPLETED
- Police Presence in Warmsworth Clerk to ask again about the possibility of police have a small "base" at the Hub - <u>ONGOING</u>

- d. Blocked culverts KGF The Contractor has been asked to schedule the work it will not take place until the weather has died out the field to enable machinery access - ONGOING
- e. Doncaster Council "ordering" tree outside Hub to be trimmed back Cllr Maxey has been dealing with this one - we are still awaiting a reply from the Asset Department at Doncaster Council - Cllr Maxey is to follow up again later this week - **ONGOING**
- f. Bees and droppings fouling properties next to Allotment Clerk has obtained some advice from the British Beekeepers and the Allotments Society - he has sent a holding email to the complainant and will follow up with the Beekeepers themselves alongside Cllrs Maxey and Laird. Cllr Cole wants the contact of the complainant so that he can have a conversation about it as well.- ONGOING
- g. Remembrance and establishment of a sub-committee meeting was held before Christmas for interested parties – there is to be an establishment of a Committee of Councillors and residents to co-ordinate the Remembrance Commemoration in future years, objectives and a meeting still needs to be scheduled- ONGOING
- h. Grosvenor Crescent cars parking on grass still some way to go over signs with disagreement between tow Doncaster Council Departments - in the meantime, the Parish Council has distributed open letters to all residents which has received a very positive response but there are a few residents who are still not respecting the green, fencing is not an option - Doncaster Councillor Cllr Cole has assisted but all-round dismay at Doncaster Council's "unprofessional" approach - ONGOING
- i. Parking on Edlington Lane, Lords Head Lane and Wrightson Update Cllr Laird / Pattison There are still issues with parking which no one appears to be enforcing - access for emergency vehicles is difficult and sometimes impossible - Cllr Cole will take this one forward with Doncaster Council Highways Department - ONGOING

### 25/036 To Hear Reports on the work of External Bodies

#### a. Allotments - Cllrs. Bennett / Laird / Maxey

Cllr laird had paid an informal visit to the allotments and had compiled a list of items which are at present outstanding:

- The Toilet needs a thorough clean The Clerk will source a suitable contractor for when the Centre Manager returns from leave
- 2. 1st Aid Kit current one not fit new one to be sourced (one also required for the Centre) the kit will be housed under the defibrillator in a box which Cllr laird may be able to source.
- 3. Ducks / Chickens and associated rats disappointment by Councillors that the plot holder has done very little - the birds are still in "inhumane conditions" and plot has not been used for purpose - the letter to the plot holder was not replied to despite multiple different contacts supplied and now thought that this person is not maintaining standards and should be evicted.
- 4. Lot 4 Plot holder paid until October, but the plot has not recently been visited as the tenant is very ill – further decisions on this will be taken when it is ascertained that the tenant cannot any longer tend to the plot.
- 5. Consideration to be given to ordering a skip Councillors thought this was ideal but only for plot waste and not for "home" items - would be done twice a year as a suggestion for a short period in April and September.

#### b. Playing Fields / Environment

Cllr Pattison commented that a complaint had been received about her "abusing" her powers an issue with St Leger Homes and a resident. Muhor

The Clerk had investigated and ruled in favour of Cllr Pattison and offered the right to appeal to the Chair and / or Doncaster Council.

- a) To consider the Formation of a "Friends Group" for the King George Field It was suggested that Councillors go away and consider the format of this body, so that further planning can take place
- b) To discuss concerns raised by Cllr Laird concerning parking on Edlington Lane, Lords Head Lane and Wrightson
  - In the evenings especially, there is very limited access to properties for emergency vehicles at night. Inconsiderate parking at the ends of the roads impede the ability for emergency vehicles to access sometimes sick patients in a traumatic state - Cllr Pattison has raised this with Highways at Doncaster Council and Cllr Cole will also add some further concern about it.
- c) To consider different lighting for and trimming of the Christmas Tree Cllr Pattison will liaise with the Clerk and with Christmas Plus after the easter break. 14/04/2018

### Erection of 109 dwellings, access, public open space, and associated infrastructure

Change of use from dwelling house (C3) to children's care home (C2) for up to 2 children and creation of additional off-road car parking space
